Non-Equity Membership

There are also a limited number of Non-Equity Memberships available. These require no bond, but greens fees for parents, children and grandchildren apply, with the exception that children under 18 play without charge after 1:00 pm. There are no voting, committee and Board privileges.

\$6,930 at inception, \$2,285 over 4 months, with 7% sales tax payable in full with first billing; includes cart for member and spouse and bag storage. Prorated monthly for new members joining after January 1.
